



Investment in Socially Responsible Mekong Region Development Bond Issued by the Export-Import Bank of India

- Contribution to improving QOL in regions

where the Dai-ichi Life Insurance Group is expanding its life insurance operations -

The Dai-ichi Life Insurance Company, Limited (President and Representative Director: Seiji Inagaki; hereinafter "our company") has purchased the full amount (approx. JPY 5.4 billion) of Socially Responsible Mekong Region Development Bond issued by the Export-Import Bank of India (hereinafter "EXIM"). The bond is the first social bond to be issued by EXIM anywhere in the world.



Funds procured by the bond will be allocated by EXIM to infrastructure development projects in Asian countries in the Mekong Region (for example, construction of power lines in Cambodia and hydroelectric plants in Vietnam, and railway modernization in Myanmar). Through the investment in this bond, our company will secure stable

revenue and at the same time provide financial support for EXIM's activities toward economic development in Asian countries in the Mekong Region. We will continuously follow up on the progress of the investment, including the development activities.

The Dai-ichi Life Insurance Group is expanding its life insurance operations in India and the Mekong Region, and aims to improve global QOL. We will contribute to further improvement of QOL by supporting economic development and solutions to social issues in these countries through this initiative.



Looking toward the future, we will aim to improve investment revenue by enhancing and diversifying our management techniques, and as a responsible institutional investor, actively engage in ESG investment activities in order to contribute to the creation of a sustainable society.

About Export-Import Bank of India (EXIM Bank)

Export-Import Bank of India ("Exim Bank") set up in 1982 under the Export-Import Bank of India Act 1981 ("Act"), is a principal financial institution in India, engaged in the activity of providing financial assistance to externally orient ed companies. Exim Bank has been established with an objective of providing financial assistance to exporters and importers, and functioning as the principal financial institution for coordinating the working of institutions engaged in financing export and import of goods and services with a view to promoting the country's international trade. The Bank is wholly owned by the Government of India and has a strong regulatory capital position. The International investment grade ratings of the Bank are at par with Sovereign ratings.
